The California Film Commission has an on-site **California Highway Patrol (CHP)** Film Liaison who is available to assist with filming on State freeways and highways. This liaison advises and schedules CHP officers for film shoots.

**Film Media Relations Officer Kristi Cardoza** is the contact for all unincorporated county roads, state highways and freeways. Officer Cardoza coordinates requests for CHP officers for film details, facilitates the approval process, and trains officers to handle the unique situations that might occur during location filming.

When filming on state property, be advised that officers are not automatically assigned and need to be reserved in advance of filming. It is the production company's responsibility to contact the CHP Film Desk a minimum of 72 hours prior to filming to determine whether officers are needed and available, and to determine if local law enforcement should be involved.
